Research shows that inclusion in general education classes is one of the predictors of improved post-school outcomes for youth and young adults with disabilities. IDEA and Chapter 14 require an individualized, assessment-based approach to secondary transition while the student is in high school. It is important that educators, agency staff, and service providers afford both rigorous, standards-aligned courses and community-based instructional experiences related to post-secondary education, employment and independent living. This session will examine effective practice, strategies, and procedures that address the individual needs of all youth and young adults transitioning to adult life.

Effective Practices: Employment Options

Employment is a building block not only for an individual's income but also for his/her health, freedom, and community engagement. Integrated employment is defined by the federal Rehabilitation Services Administration (RSA) as self-employment or work in an integrated setting that is performed on a full or part-time basis that is at least equal to the higher of the federal or state minimum wage. RSA and other disability organizations have recognized the value of integrated and competitive employment, and have made obtaining either one of them, and reducing dependence on sheltered employment, national goals. There have been various strategies introduced to ensure that individuals are successful in integrated settings, including the use of supported and customized employment. This webinar will present information regarding effective practice, programs, and activities that lead to successful employment outcomes for youth and young adults with disabilities.
